## EXPLORATION UPDATE MT/IP SURVEYS COMMENCE AT TORO SOUTH TMT PROJECT, ARGENTINA


### **KEY HIGHLIGHTS**

- **Geophysical MT/IP surveys underway at Toro South** to further define targets ahead of potential drilling in Q4 CY25.
- MT/IP surveys can image zones of low resistivity from surface to depths of over 2,000m and have been successfully used in copper porphyry projects globally for refined drill hole targeting, such as ATEX Resources' nearby Valeriano project (1.51Bt @ 0.75% CuEq)<sup>1</sup> (~20 km northwest of the Toro South target).
- Drill contract negotiations with a global leader nearing completion, mobilisation to site is planned for late November.
- Age dating of intrusive rocks at Toro and Tambo South confirms magmatic ages between ~25 Ma and ~19 Ma consistent with major copper porphyry systems in the Vicuña Belt (Josemaria, Filo del Sol). These age dating results further enhance the prospectivity of Toro and Tambo South to host fertile intrusions for copper porphyry mineralisation.

**Managing Director Arvind Misra commented**: "The MT/IP survey now underway at Toro South is a key step in unlocking the project's full potential. These advanced surveys will help us pinpoint high-priority drill targets within what we believe is a large and fertile mineralised system.


Combined with recent age-dating results confirming the same magmatic window as major porphyry copper deposits in the Vicuña Belt — such as Josemaria and Filo del Sol — we're building a strong geological foundation ahead of drilling later this year.

With drill contracts nearing completion and mobilisation planned for late November, Belararox is well positioned to deliver meaningful exploration progress in Argentina's most exciting copper province."


**Figure 1.** Targets from ASTER and SENTINEL 2 interpretation, for more information see BRX ASX Release (Amended ASX Release 18 May 2023). Note on target ranking: A-class targets are of higher priority than B-class targets. Within each target class, targets are prioritised from 1 (highest) to 3 (lowest). However, the sensitivity of the ranking method is coarse, such that there may not be a significant difference in the prospectivity of targets prioritised as 1 and 2 in each class (e.g. A1 > A2).

### **Toro South**

Belararox's Toro-Malambo-Tambo (**TMT**) project is situated within Argentina's San Juan Province and occupies an unexplored area between the prolifically mineralised El Indio and Maricunga Metallogenic Belts.

The Toro South target sits at the junction of two major regional faults, only 20km southeast of ATEX Resources' Valeriano Project (current MRE of 1.41 billion tonnes at 0.67% CuEq and recent US\$40m strategic investment in ATEX by Agnico Eagle Mines Limited).<sup>1</sup>






**Figure 2.** Overview of BRX's TMT project and Toro South target. The black inset on the left image shows the extent of the right image. Note the regional faults (white lines) and proximity to existing deposits and mining operations.

Surface rock sampling at the Toro South target has returned assay results of up to 1.41% Cu, 1.28 ppm Au, 421 ppm Ag, 8.13% Zn, and >20.0% Pb (see Figure 3 and BRX ASX release dated 3 July 2025). These assay results are supported by anomalous pathfinder elements, including Tl, Li, As, Sb and Bi.





Figure 4: Geological cross section (looking north) for the Toro South target (see figure 3 for plan view location), showing indicative drill holes TMT-TOS-DDH-001 and TMT-TOS-DDH-002 targeting interpreted epithermal and porphyry targets. Note: The numbers on the iso surfaces represent probability scores (0-1) of the geochemical models at Tambo matching with the reference metal-zoning models from Cohen (2011). Values over 0.15 are considered 'significant', with a maximum score of 1.00, which corresponds to a 100% match.

3D interpretation of surface assay results from Toro South has confirmed the presence of a significant copper porphyry target at depth. Anomalous copper, gold, and silver values from the surface also highlight the potential for an epithermal system developed above this porphyry target (Figure 4).

### MT/IP Geophysical Survey

A combined magnetotellurics (MT) and induced polarisation (IP) geophysical survey has started at the Toro South and Central targets. The survey is instrumental to further characterise the most prospective zones for follow-up drill targeting over an area of approximately 2,500m by 2,500m covering the entire Toro South target and the most prospective zones of the Toro Central target (see Figure 5).

MT/IP surveys can image zones of low resistivity from the surface to depths of over 2,000m. Areas of Cu porphyry mineralisation typically coincide with low MT resistivity anomalies and have been successfully used in Cu porphyry projects elsewhere for refined drill hole targeting, such as the nearby Valeriano Deposit from ATEX Resources (~20 km northwest of the Toro South target, see https://www.atexresources.com/valerianoproject/geophysics/).

### Geochronology




Figure 7: Location of samples TOR-002 and TOR-003 at the Toro prospect.





Figure 8: Location of samples CLRK0011161 and CLRK0011162 at the Tambo South prospect.

Two rock chip samples from Toro (one sample from Toro South and one rock chip sample from Toro Central, see Figure 7) were sent to the Curtin University facilities in Perth, and a further two samples from Tambo South (see Figure 8) were sent to the CODES Analytical Laboratories in Tasmania, to determine their magmatic ages based on zircon U-Pb geochronology and to characterize trace element contents in zircon.




**Figure 9:** Interpreted magmatic ages from Toro and Tambo South compared with major Cu deposits nearby. Baseline deposit ages derived from Perello et al. (2023).

In each sample a coherent population of young zircons was identified and are interpreted to be the magmatic age of the samples. The ages of the two samples in Toro are 25 + -1 Ma (TOR-002) and 23.17 + -0.79 Ma (TOR-003), the ages of the two samples at Tambo south are 19.04 Ma +-0.52 Ma (CLRK0011161) and 19.14 Ma +-0.31 Ma (CLRK0011162; see Figure 9 and Table 1).




**Figure 10**: Zircons from samples TOR-002 and TOR-003 are plotted against zircons from ore-stage intrusions in four porphyry copper deposits (El Teniente, Jiama, Quellaveco, and Pulang) are compared with zircons in pre-ore intrusions (Toquepala Granodiorite in Peru and Kaskanak diorite in the Pebble district, Alaska), and in infertile igneous units in unmineralized regions (Oruanui rhyolite tuff, Lucerne granite). After Loucks et al. (2024).

As there is a well-established link between the zircon chemistry and the potential of the system to be ore forming the trace element data from the younger populations was used to calculate the Zircon Fertility Index via the methodology of Loucks et al (2024) (see Figure 10).

- Geophysical MT/IP surveys data to be interpreted once complete to further refine targets ahead of potential drilling in Q4 CY25.
- Drilling contract negotiations with a global leader nearing completion, mobilisation to site is planned for late November.

- The Filo del Sol deposit has an estimated Total Mineral Resource of 644Mt @ an average grade of 0.31% Cu, 0.32g/t Au, & 10.1 g/t Ag with cut-off grade varying for elements, oxide, sulphide, and AuEq, refer to source document for the cut-off grade (Ausenco Engineering Canada Inc, 2023). The Filo del Sol deposit is associated with oxide & sulphide ores that are strongly associated with siliceous alteration (mapped silica and residual quartz), surrounded by quartz-alunite alteration.
- The Filo del Sol Cu-Au-Ag deposit has been used as a geological analogue since it shows a similar response to the siliceous alteration (silica and residual quartz) and similar regional structural features, with N-S major lineament crosscut by a NW-SE structure.
- Veladero Geological Analogue (Holley, 2012)
- The Veladero deposit displayed clear links between the ASTER thermal image and the surface-mapped silica / residual quartz alteration. The final pit predominantly targeted the surface ASTER interpreted Jarosite & Pyrophyllite.
